Engineering

Approval of Cooperative Agreement Between MNDOT, Washington County, and the City of Oakdale for Construction Cost of County State Aid Highway (CSAH) 14 Signal and Trail Project.

Brian Bachmeier, Interim City Engineer, provided Council with information from MnDOT. MnDOT requires an agreement with the City of Oakdale and Washington County to provide funding for the project, and to assign maintenance responsibilities. Washington County will be responsible for major maintenance, and the City will be responsible for minor maintenance. This is similar to other trails located within County ROW Recommendation is to approve the agreement with MNDOT and Washington County.
